The finance company allows only one cheque. to be written only as a favour

to you. When they are the same, they ask for your consent in writing. In such a case, the bank has the right to take the usual deductions to recover the amount due by you. It is customary for the bank to debit your account with interest and charges. Also, you should avoid written agreements with the bank and companies which ask you to write their cheques because they may become your victims later. All commercial banks account for more than 10% of the written cheques which you hand in and ask them to deduct the amount. When they ask for your consent in writing, you should give the consent. If you knowingly refuse to give the consent, you may be taken to the Commercial Court by the bank and the company without notice of any kind. By the way, when you write a cheque on the bank account of any company or individual, they may deduct the amount from your account. It is important to know the following in such a situation: The Commercial Court will give the company and the bank the right to take any sum from you without giving you any opportunity to apply to the court for a decision on the amount to be deducted from your account. You may, at any time, ask the court to give you an opportunity to be heard on the deductions. After taking these deductions, you may apply to the court to examine the reasons why the amount was deducted. The court will award you money against the company and the bank and the amount will be paid to you by the bank. If the bank and the company fail to pay you the amount, you can sue
